Welcome to our latest quarterly newsletter



It has been a busy period for Government and the Department over the last few months.

The release of the Surface Fleet Strategy, the Defence Industry

Development Strategy, the passing of the Defence Export Controls legislation, the announcement of the submarine capability partners, and we are told the release of the Defence Integrated Investment Plan, all tying together in the Governments next budget in May.

There have been some large spending announcements with approximately \$4.7 billion being sent to the US to assist with production line issues for the Virginia Submarines and \$5 billion being sent to the UK for Rolls Royce to ensure that the nuclear reactor production line is capable of supplying reactors for the SSN AUKUS submarines.

Recently released data indicates that the spend rate within our domestic market has reduced, and whilst the data indicates that Government will be operating around their stated 2% of GDP for Defence – a lot of that spend is heading directly offshore. As I pointed out in the last paragraph almost \$10 billion is going to ensure that the industrial basis of the US and UK are being maintained, and this large amount of taxpayer's money contributes to the Government achieving their stated defence spend.

We see more SMEs working harder to achieve smaller returns in order intake, and this is reflected by my discussions with many of you.

What we need to see from Government is a clear commitment in the IIP for programs that are fully funded – Australian Industry needs certainty; with certainty our domestic industrial base can plan appropriately, consider what it needs to invest in and work to attract and maintain the workforce it needs to ensure that we are achieving the outcomes Australia the nation needs, we need a vibrant domestic industry to ensure our national strategic resilience is achieved.

The IIP will reflect the Governments ambitions as set out in the DSR, we as an industry must be ready to adapt to those requirements. The Government also needs to play its part in these endeavours by ensuring Australia's local industry is treated fairly and equitably.

The Government cannot simply send \$10 billion overseas, claim they are achieving their intent of Defence spend as a percentage of GDP, claim victory, and move on.

Australia's indigenous industry deserves to have the same amount of attention and allocation of funding to ensure that it too is viable and that it also is ready to supply into these programs.

This is the only way to ensure that we achieve the maximum return on investment to the Australian taxpayer and ensure that we create an industry in Australia that can contribute to global supply chain.

We all should be watching how this develops over the next several months.

AIDN has spent the last few months working closely with Defence in providing advice on how best to ensure that our above the line contractors remain in a viable position, our SME community provides valuable services to Defence in this space and contributes to the support



of our veteran community by ensuring they have viable long term jobs, jobs that allow them to continue to support the ADF. This process has enabled AIDN and Defence to forge a good working relationship and this allows the voices of our ATL contractors to be considered in the decision-making process, this will be an ongoing activity and we have been supported by many of our AIDN members ensuring that Defence is hearing directly from those providing the services and operating in this environment. We will provide more regular updates on this activity going forward.

Another area of concern to AIDN is the fallout to the supply chain with the Government's announcement of the reduction of the number of OPVs and Hunter Class surface vessels. This reduction in numbers will have a direct effect on many of your businesses. AIDN will continue to make representations to both the Department and the Government on this issue. We understand that for many of you, advanced orders were placed, contracts signed with pricing provided based on numbers of vessels and critical capability and investment made. Whilst we understand that Government will always determine the equipment it acquires based on advice from Defence, Government and Defence also need to treat these suppliers fairly when decisions are changed.

We have seen several large contracts altered or cancelled over the last few years, the Attack Class submarine, MRH 90 Helicopters, reduction in number of



vehicles for Land 400 Ph 3, a halving of the number of OPVS and the reduction by 33% of the number of Hunter class frigates. These decisions come with consequences to our industrial base, and Government needs to ensure that our local industry is commercially looked after and wherever possible fast tracked to new programs to minimise the impact on our Australian Industry.

It is important that you as members reach out to AIDN and tell us what is happening to your businesses; with that information we can reach directly into Government and Defence to attempt to effect change.

There is much happening, and it is important that you are aware of all these changes – AIDN will be providing a series of information webinars encompassing a broad range of topics, Export Controls, AUKUS, DISP, Cyber, and business winning, to name a few topics. I urge you to register for these events as they come up.

Veteran Employment Campaign

While the hearings for the Royal Commission into Defence and Veteran Suicide have now concluded, the resolve of the Albanese Government to support veterans and families remains

undiminished, including our focus on supporting veterans' transition to civilian life.

One of the key factors to having a successful transition is finding fulfilling civilian work post service.

I know many of you in Defence industry know this intimately – either as ex-service people yourselves, or working alongside many colleagues who have previously served in the ADF.

Defence industry by all accounts is one of the key civilian industries that veterans transition to following their lives in Defence, which leverages their unique skillset and continues to provide that sense of purpose people often strive for in joining the ADF in the first place.

At the last election the Albanese Government committed to a \$24 million veteran employment campaign. That's now in full swing and I wanted to share with you a few ways you can get involved.

As part of this we have renewed the Veteran Employment Commitment, asking civilian organisations to more clearly demonstrate how they are supporting veterans in the workplace.

There are three tiers of this commitment – Veteran Employment Supporter, Veteran-Friendly Employer and Veteran Employer of Choice.

Organisations that sign up to the Veteran Employment Commitment will now need to demonstrate what they're doing to support veterans into civilian employment, through



recruitment, support and leadership in the workplace.

The Commitment also includes an assurance businesses will not encourage current serving ADF members to leave service.

Ultimately this commitment seeks to assist veterans to better identify organisations that are appropriate for them, with businesses demonstrating their workplace policies and programs specifically targeted at helping veterans perform at their best.

To bring this all together, a national campaign has been launched to share the benefits of employing ex-service personnel in the civilian workplace.

The Australian Defence Force is an incredible training ground for personnel, but when they leave service, many report having difficulty translating their skills from the ADF to the civilian workplace.

Ex-service personnel can bring skills like leadership, teamwork, agility and the ability to work under pressure to the

You certainly reap the benefits of this in Defence industry but the impact of this has the potential to be much wider reaching.

This new national campaign will share the stories of five ex-service personnel in the civilian workplace, in professions you might not expect.

This campaign seeks to educate employers on the diversity of skills ex-service personnel can bring to the workplace and provide advice to make sure ex-service personnel are set up to thrive in the civilian workplace.

This campaign is aimed at boosting veteran employment opportunities, as well as help businesses benefit from the diverse skill sets that veterans bring.

Nominations are also now open for the 2024 Prime Minister's National Veteran Employment Awards, which will celebrate leading veteran employers and employees.

These awards will identify talented individuals and organisations working to ensure veterans and their partners thrive upon their transition out of the Australian Defence Force.

Veterans provide invaluable contributions to the civilian workforce and these awards highlight their achievements as well as the



organisations that recognise and support them.

Nominations for the Awards are open now and close on 31 May 2024.

For those of you who are veterans, you're likely familiar with the convoluted and overly complex process of gaining support through the Department of Veterans' Affairs.

We're working to simplify and harmonise veterans' compensation legislation into a single Act so veterans and families can more easily access the support they're entitled to.

Consultation on the proposed legislation is now underway, you can learn more and make a submission through the DVA website before 28 April 2024.

Finally, as we approach Anzac Day, I want to acknowledge all of your contributions to the defence of our nation and your support of both our current and former serving Defence personnel.

The contributions of our Australian Defence industry now are as important as ever. The Defence Strategic Review observed that we are facing the most

complex strategic circumstances since the Second World War, and close partnership between Government and industry is critical.

The AUKUS technology partnership presents an unprecedented opportunity to harness innovation and invest in a generational uplift in our industrial and defence capabilities.

As we gear up to build and sustain conventionally armed, nuclear-powered submarines in Australia, the relationship between industry and current serving personnel is only set to grow.

This is already in train, with Australian Navy personnel undertaking training in the US to develop the skills to work on nuclearpowered submarines. This is the first time that Australians have been involved in learning and working on American conventionally armed nuclear-powered submarines.

In the next year, there are plans for 100 ASC personnel to head to Pearl Harbour to also gain these skills to eventually contribute to the sustainment of conventionally armed, nuclear-powered submarines in Australia.

Through the Skills and Training Academy in South Australia and South Metropolitan TAFE in WA, we've begun investing now, to support the workforce we will need to realise AUKUS over the coming decades.

The continued pursuit of Australia's defence and national security continues the proud tradition of the ANZACs working alongside our friends in the interests of our values and beliefs.

This year and every year we express our gratitude to the generations of Australians who have donned a military uniform in the service of our nation.

On Anzac Day, in towns and cities across Australia and around the world, Australians will gather to acknowledge the commitment of our current and former serving personnel and all those who contribute to our nation's defence. We reflect on their sacrifices and those of the families who support them.

Lest we forget.

All ahead flank on AUKUS, and keeping a close eye as we go*

Over the last couple of years, Australia has had to rethink our defence posture, to build our capacity to deter an adversary and to maintain our warfighting edge.

Before Easter, Parliament

passed important bipartisan legislation to facilitate AUKUS, execute the plan and build out the security and regulatory framework that will bring AUKUS Pillar I and Pillar II to life.

The 2024 National Defense Authorization Act was passed by the US Congress on 15 December 2023. This has huge significance for Australia.

Specifically, it authorises the transfer of three Virginia class submarines to Australia. It also authorises the maintenance of US nuclear submarines in Australia, a critical condition for the success of the Optimal Pathway and its first key objective: Submarine Rotational Force – West. It offers opportunities for small to medium enterprises, not only but particularly in Perth, who can be part of the supply chain and deep sustainment for our US and UK partners. It will include our submarines when they pass into our hands.

The NDAA authorises Australian contractors to train in US shipyards to support the development of Australia's submarine industrial base. It also establishes a mechanism for the US to accept Australian investment to lift the capacity of the US industrial base, particularly their shipyards, which will increase the submarine delivery cadence, which must increase. The NDAA also gives Australia a national exemption from US export control licensing requirements, enabling a freer flow and transfer of controlled goods and technology between our three countries, enabling Pillar II particularly. Finally, it adds Australia and the UK to Title 3 of the US Defense Production Act, opening new opportunities for Australian small to medium enterprises as the US production base expands. I acknowledge for many Australian defence businesses, it's not been easy, but we want it to become easier. And the NDAA, and our own legislation, are important milestones in that journey.

Understandably, academic and defence industry stakeholders have considered these developments carefully. Genuine concerns have been raised. Concerns about the regulatory burden and unintended consequences, but there has also been a recognition of the national interest, and the need to move faster. I'm counting on defence industry in particular to continue voicing your views and bringing your concerns to Government in the national interest. Where improvements can be made, let's say so.

I'm very glad as the Australian legislation was being finalised, Government agreed to the Opposition's calling for Australian defence industry stakeholders to be included in the new regulatory co-design process. The working groups should include Australian owned small- to mediumsized enterprises. It's important they have a voice and I'm glad the Government accepted that recommendation.

I should also note the Deputy Prime Minister's commitment to establishing a joint statutory committee on defence. This has been a long-term project for parliamentarians from both sides. I think that when Australians go to war we should all support our troops in the field, but there should be a forum where we can ask hard questions of our military leadership particularly on strategy and operations. The committee also has an important role to play overseeing the 'business' of Defence, how public money is invested and spent, and what we're getting for it.



I should also note the Deputy Prime Minister's commitment to establishing a joint statutory committee on defence. This has been a long-term project for parliamentarians from both sides. The new committee also sends a signal to the US and to the UK that we're serious about getting the best and the most out of Defence, by holding them accountable that we ask the right questions but that we do it behind closed doors. Bound by secrecy provisions, constituted by the parties of government, with sensible people and serving as a training ground for future defence ministers. I welcome the Deputy Prime Minister's willingness to move at speed on this.

It's worth now highlighting some concerns about Submarine Rotational Force – West. We know that works to upgrade HMAS Stirling don't begin until 2025, so timing is tight and I urge the Government to get a move on. I'm also concerned about the housing shortage in WA. Many of us across the country feel the housing shortage; it's acute. But if we're going to have US and UK families coming to WA, it's going to be even more acute. We talk about 'social licence' for nuclear powered submarines; I think there's also a social licence required for foreign personnel living alongside Australians, particularly when there's an existing housing shortage. We need to get more houses built as fast as possible so we can welcome our friends when they arrive in 2027.

Finally, I remain deeply troubled by the recruitment and retention crisis in the ADF. We know the ADF is below strength. We know we're not hitting targets. We want to see more people in uniform serving our country. Many in defence industry have served and continue to serve in the reserves. Many former personnel have sons and daughters serving and wanting to serve. The message has to be one of patriotism, one of opportunity and one of aspiration, and we need to get cracking with this next generation.

As always, please let me know if we can work together in improving the conditions and prospects for Australian defence industry, and for supporting our defence personnel.

We have seen recent engagement for Defence Industry by federal and industry stakeholders. Following are a selection of the forums held in the NT;

Mid December the Defence Minister The Hon Richard Marles MP hosted a round table for Defence Industry representatives at RAAF Base Darwin. This was an opportunity for local industry to provide direct feedback to the Minister, and to raise questions concerning the direction of outcomes from the DSR in relation to local Defence Industry. Defence State ready to deliver continuous shipbuilding

With the release of the Australian **Government's long-anticipated Surface** Fleet Review, South Australia has been confirmed as the home of major surface combatants.

The review into the Royal Australian Navy's surface fleet requirements revealed that while the number of Hunter class frigates would be reduced from nine to six, the build of the replacement vessel for the Hobart class destroyer will immediately follow at the Osborne Naval Shipyard.


Under the new plans, the construction of the Hunter class frigates will sustain at least 2,000 South Australian jobs and create at least 500 new jobs over the next decade. This is in addition to the estimated 4,000 jobs to build the new Submarine Construction Yard at Osborne and the more than 4,000 direct jobs to build the nuclearpowered submarines.

The work program for the Osborne shipyard now includes:

- construction of Hunter class frigates
- construction of SSN AUKUS submarines




